ORDER ASSESSING ADMINISTRATIVE PENALTY FOR VIOLATION OF INJUNCTIVE ORDER

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Assessing Administrative Penalty for Violation of Injunctive Order against Simpletuition Inc. ("SimpleTuition").¹

Statement of Facts and Law

SimpleTuition is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. SimpleTuition operates under master file number 12133 at one licensed location, under license number 50942. SimpleTuition's compliance officer is Emily Herring, and its designated contact address is 268 Summer St.; Ste 502, Boston, Massachusetts 02210.

A regulated lender must file annual reports with the Consumer Credit Commissioner ("Commissioner").² A regulated lender must file the required annual report by May 1 for the prior year's calendar loan activity on forms prescribed by the Commissioner and must comply with all instructions relating to submitting the report.³

On May 26, 2016, the OCCC issued an Order to File Timely and Accurate Reports against SimpleTuition for failing to timely file its 2015 annual report. SimpleTuition did not request a hearing on the Order and a Final Order was issued July 14, 2016. The Order required SimpleTuition to timely file complete and accurate future annual reports.

SimpleTuition did not file its 2017 annual report with the Commissioner by filing deadline of May 1, 2018. In correspondence dated May 8, 2018, the OCCC notified SimpleTuition that its 2017 annual report had not been received and extended the deadline for filing to May 18, 2018. As of the date of this Order, the OCCC has not received SimpleTuition's 2017 annual report.

Order

IT IS ORDERED that Simpletuition Inc.:

- 1. pay an administrative penalty in the amount of \$500.00. This penalty is calculated as \$500.00 each for SimpleTuition's one licensed location, within 30 days of service of this Order;⁴ and
- 2. file its 2017 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

Response and Right to Request Hearing

You have the right to request a hearing regarding this Order.⁵ Your request must be made in writing and sent to the OCCC not later than 30 days after you receive this Order. You must send your request to:

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁶ If
