# ORDER ASSESSING ADMINISTRATIVE PENALTY FOR VIOLATION OF INJUNCTIVE ORDER

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Assessing Administrative Penalty for Violation of Injunctive Order against Altruistic Hearts Healthcare PLLC d/b/a Helping Hands Cash Advance and Payday Loan ("Helping Hands Cash").<sup>1</sup>

#### Statement of Facts and Law

Helping Hands Cash is a credit services organization licensed to act as a credit access business under Chapter 393 of the Texas Finance Code. Helping Hands Cash operates under master file number 1700058573 at one licensed location, under license number 157946. Helping Hands Cash's compliance officer is Reginald Reed, and its designated contact address is 7544 FM 1960 Rd. East, Suite 311, Humble, Texas 77346.

A credit access business must file quarterly and annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A credit access business must submit its quarterly and annual reports on or before the following dates:

- 1st quarter report April 30;
- 2nd quarter report July 31;
- 3rd quarter report October 31; and
- 4th quarter and annual report January 31.3

If a credit access business fails to timely file its quarterly or annual reports within four quarters of failing to timely file a previous report, the OCCC may assess an administrative penalty of \$500.00 for each licensed location.<sup>4</sup> If a credit access business fails to file its quarterly report three or more times within four quarters of the second offense, the OCCC may assess an administrative penalty of \$1,000.00 for each licensed location.<sup>5</sup> Upon a fourth offense within four quarters of three or more offenses, the OCCC may seek the revocation of a business' license.<sup>6</sup>

On June 15, 2018, the OCCC issued an Order to File Timely and Accurate Quarterly and Annual Reports against Helping Hands Cash for failing to file its 2018 1st quarter report.

Helping Hands Cash did not file its 2018 3rd quarter report with the Commissioner on or before October 31, 2018. Additionally, Helping Hands Cash did not timely file one or more of its reports within the four quarters preceding the 2018 3rd quarter report.

## Order

IT IS ORDERED that Altruistic Hearts Healthcare PLLC d/b/a Helping Hands Cash Advance and Payday Loan:

- 9. pay an administrative penalty in the amount of \$500.00, calculated as \$500.00 each for Helping Hands Cash's one licensed location, within 30 days of service of this Order; and
- 10. file its 2018 3rd quarter report within 30 days of service of this Order, if it has not already done so.

Credit access business quarterly and annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov. A check made payable to 'Office of Consumer Credit Commissioner' may be mailed to 2601 N. Lamar Blvd., Austin, Texas 78705, for payment of the \$500.00 penalty.

# Response and Right to Request Hearing

You have the right to request a hearing regarding this Order. Your request must be made in writing and sent to the OCCC not later than 30 days after you receive this Order. You must send your request to:

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code. If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.
