**License Suspension and Revocation Actions**

Name: Cedar Creek Cars & Trucks LLC, 121 N Seven Points Blvd., Seven Points, Texas 75143

Background: The OCCC initiated an enforcement action to revoke Cedar Creek's license for violations of: (1) Section 348.408 of the Texas Finance Code by failing to provide payment on the full balance of trade-in vehicles within 25 days of the trade, (2) Section 349.001 of the Texas Finance Code by failing to refund excessive public official fees, and (3) Title 7, Section 84.708 of the Texas Administrative Code by failing to maintain records of trade-in vehicle payoffs and public official fee refunds.

Disposition: Following a hearing before an administrative law judge, Commissioner Pettijohn adopted the recommendation of the proposal for decision and issued a final order revoking Cedar Creek's license.

Background: The OCCC initiated an enforcement action to suspend Gene Fogle's license for violations of: (1) Section 348.005 of the Texas Finance Code by charging excessive public official fees, (2) Section 348.006 of the Texas Finance Code by charging unauthorized documentary fees, (3) Section 349.001 of the Texas Finance Code by failing to refund excessive public

official fees and unauthorized documentary fees, and (4) Title 7, Section 84.703 of the Texas Administrative Code by failing to perform a self-review for excessive public official fees and unauthorized documentary fees.

Disposition: The OCCC issued an agreed order assessing a \$15,000 administrative penalty and imposing one year of probation.

Disposition: The OCCC issued an agreed order assessing a \$10,000 penalty.
