**ORDER IMPOSING ADMINISTRATIVE PENALTY**

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against Tax Loans USA Ltd. (“Tax Loans USA”).<sup>1</sup>

**Statement of Facts and Law**

Tax Loans USA is a property tax lender licensed by the OCCC under Chapter 351 of the Texas Finance Code. Tax Loans USA operates under master file number 14934 at one licensed location, under license number 54551. Tax Loans USA’s compliance officer is Daniel Schreimann, and its designated contact address is 8445 Freeport Pkwy., Ste. 175, Irving, Texas 75063.

A property tax lender must file annual reports with the Consumer Credit Commissioner (“Commissioner”).<sup>2</sup> A property tax lender must comply with all instructions from the OCCC relating to submitting the report.<sup>3</sup> The report is due by March 31 of each year for the prior calendar year’s loan activity.<sup>4</sup>

On June 25, 2021, the OCCC issued an Order to File Timely and Accurate Annual Reports (the “Order”) against Tax Loans USA for failing to timely file its 2020 annual report. The Order required Tax Loans USA to timely file all future annual reports.

Tax Loans USA did not file its 2021 annual report by March 31, 2022, for one licensed location, under license number 54551.

The Commissioner may issue an injunction ordering a property tax lender to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the property tax lender is violating Chapter 351 of the Texas Finance Code.<sup>5</sup> The Commissioner may impose an administrative penalty on a property tax lender that violates an injunction.<sup>6</sup>

By failing to timely file its 2021 annual report, Tax Loans USA has violated Chapter 351 of the Texas Finance Code and the OCCC's Order to File Timely and Accurate Annual Reports.

## **Order**

IT IS ORDERED that Tax Loans USA Ltd.:

1. pay an administrative penalty in the amount of **\$500.00**, calculated as \$500.00 each for Tax Loans USA's one licensed location, within 30 days of the date of this Order; and
2. file its 2021 annual report within 30 days of the date of this Order, if it has not already done so.

Property tax lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): [alecs.occ.texas.gov](http://alecs.occ.texas.gov). Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, [occ.texas.gov](http://occ.texas.gov).

## **Right to Request Hearing**

You have the right to request a hearing regarding this Order. To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after the date of this Order.
