ORDER IMPOSING ADMINISTRATIVE PENALTY FOR VIOLATION OF CEASE AND DESIST ORDER

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty for Violation of Cease and Desist Order against Pyne RV Rentals, Inc. d/b/a Auto & RV World of Texas and d/b/a Auto World of Texas ("Pyne RV") and Texan RV Ltd. ("Texan RV") based on the violations of law described below.¹

Statement of Facts and Law

The Consumer Credit Commissioner ("Commissioner") may issue an injunctive order to enforce compliance with Chapters 348 and 342 of the Texas Finance Code.² If a hearing is not timely requested, the order is considered final and becomes enforceable.³ The Commissioner, after giving notice, may impose an administrative penalty for violation of the injunctive order, in an amount not to exceed \$1,000 for each day of violation.⁴

On October 23, 2019, the OCCC issued an Order to Cease and Desist Unlicensed Activity and Make Restitution (the "Cease and Desist Order") against Pyne RV and Texan RV for violating Chapters 348 and 342 of the Texas Finance Code by engaging in unlicensed activity under these chapters. ⁵ On October 23, 2019, the OCCC sent the Cease and Desist Order to Pyne RV and Texan RV by regular mail and by certified mail, return receipt requested. The Cease and Desist Order required Pyne RV and Texan RV to:

- 1. comply with the motor vehicle sales finance license requirement, found in Sections 342.051 and 348.501 of the Texas Finance Code;
- 2. cease any and all unlicensed activity under Chapters 342 and 348 of the Texas Finance Code;
- 3. review all motor vehicle sales transactions from August 13, 2015 to October 1, 2019 to identify each retail installment transaction in which it acted as a holder without a license under Chapter 348;
- 4. review all motor vehicle sales transactions from August 13, 2015 to October 1, 2019 to identify each transaction it made, transacted, or negotiated, or charged or received a charge, subject to Chapter 342 of the Texas Finance Code without the required license;
- 5. no later than December 1, 2019, refund all finance charges that you collected or that remain collectible in the transactions you identified above;
- 6. no later than December 1, 2019, provide the OCCC with a spreadsheet of all transactions you identified and all buyers that you gave a refund. This list must include the buyer's name, account number, transaction date, amount financed, amount of finance charges, and refund amount; and
- 7. keep a copy of each customer's refund check or payment history showing an account credit until the expiration of the required retention period.

The Cease and Desist Order notified Pyne RV and Texan RV that it may be subject to an administrative penalty of up to \$1,000 per day for violating the Order. On January 21, 2020, the OCCC sent a Final Notice letter to Pyne RV and Texan RV stating the Cease and Desist Order had become final and enforceable.⁶

As of the date of this order, Pyne RV and Texan RV have not provided the OCCC with proof of refunds and restitution, in violation of the Cease and Desist Order.

Penalty Amount

The Commissioner has determined that an administrative penalty should be imposed against Pyne RV and Texan RV for violating the Cease and Desist Order.⁷ In determining the administrative penalty amount the Commissioner has considered the following factors⁸:

- (1) the seriousness of the violation, including the nature, circumstances, extent, and gravity of the prohibited act;
- (2) the extent of actual or potential harm to a third party;
- (3) the history of violations;
- (4) the amount necessary to deter future violations;
- (5) efforts to correct the violation; and
- (6) any other matter that justice may require.

Order

IT IS ORDERED that Pyne RV Rentals, Inc. d/b/a Auto & RV World of Texas, Texan RV Ltd. d/b/a Auto & RV World of Texas, and Pyne RV Rentals, Inc. d/b/a Auto World of Texas pay an administrative penalty in the amount of **Twenty Thousand Dollars (\$20,000.00)**. This administrative penalty must be paid no later than June 1, 2020.

ORDER TO CEASE AND DESIST UNLICENSED ACTIVITY AND TO MAKE RESTITUTION

The Office of Consumer Credit Commissioner ("OCCC") issues this Order to Cease and Desist Unlicensed Activity and to Make Restitution against Pyne RV Rentals, Inc. d/b/a Auto & RV World of Texas and d/b/a Auto World of Texas ("Pyne RV") and Texan RV Ltd. ("Texan RV") based on the violations of law described below.¹

Statement of Facts and Law

A person is required to have a license issued under Chapter 348 of the Texas Finance Code in order to act as a holder of a motor vehicle retail installment contract.² A person is required to have a license issued under Chapter 342 of the Texas Finance Code in order to make, transact, or negotiate a loan.³

Pyne RV Rentals, Inc. d/b/a Auto & RV World of Texas

Pyne RV Rentals, Inc. is a Texas corporation that is authorized to do business under the assumed name "Auto & RV World of Texas." Its principal place of business is 26304 Katy Freeway, Katy, Texas 77494. Pyne RV's President and registered agent is Neil Pyne.

Pyne RV holds a license issued by the Texas Department of Motor Vehicles authorizing it to act as a salvage vehicle dealer at 26304 Katy Freeway in Katy, Texas. Pyne RV operates as a salvage vehicle dealer under license number 079251761, dealer number 51761, and the assumed name of Auto & RV World of Texas.⁵ However, Pyne RV does not currently hold a dealer's license (general distinguishing number) issued by the Texas Department of Motor Vehicles authorizing it to sell motor vehicles.⁶

Pyne RV previously held a license issued by the OCCC to finance the sale of motor vehicles under master file number 13356 and license number 53595 at 26304 Katy Freeway, Katy, Texas from May 2, 2008, through August 13, 2015. Pyne RV does not currently hold an OCCC license.

In January 2018, an OCCC investigator visited the business located at 26304 Katy Freeway, Katy, Texas. The sign at the business advertised itself as Auto & RV World of Texas, advertised its website as "www.rvworldtexas.com", and advertised its telephone number as 281-392-7963. This name, address, and telephone number are identical to the information for Pyne RV's license number 53595 in the OCCC records.

The OCCC investigator observed that the business was displaying a printed OCCC motor vehicle sales finance license bearing license number 13356-53595. The displayed license indicated the license was active, even though this license had expired more than two years earlier, on August 13, 2015. Pyne RV's display of a printed OCCC license when Pyne RV did not in fact possess an active license constitutes a false, misleading, and deceptive representation in violation of the Texas Finance Code.⁷ In addition, Pyne RV's display of a printed OCCC license when Pyne RV did not in fact possess an active license constitutes a device, subterfuge, and pretense to evade the application of the requirement to hold a license to engage in retail installment transactions.⁸

Pyne RV has continued to engage in unlicensed activity under Chapter 348 of the Texas Finance Code by continuing to sell and finance cars without a valid license from the OCCC.⁹ Pyne RV may have engaged in the financing of motor vehicle sales in 42 transactions, where the retail installment contracts were thereafter sold to Westlake Services for collection.

Pyne RV Rentals, Inc. d/b/a Auto World of Texas

Pyne RV Rentals, Inc. has also filed an assumed name certificate with the Texas Secretary of State to operate as Auto World of Texas. Pyne RV is selling motor vehicles at 8321 Hempstead Road in Houston, Texas under the assumed name of "Auto World of Texas." A Google maps image of this location shop signs identifying the business as "Auto World of Texas." In February 2018, an OCCC investigator visited the business located at 8321 Hempstead Road in Houston, Texas. The sign at the business advertised itself as Auto World of Texas.

An advertisement on a website that purports to offer credit must disclose the legal or registered name of the advertiser, and the street address of the advertiser's place of business. ¹⁰ The records of the Texas Secretary of state reflect Pyne RV is the only person authorized to conduct business under the assumed name of "Auto World of Texas." ¹¹ As described below, Pyne RV doing business

under the name "Auto World of Texas" is advertising on two websites that purport to offer credit to consumers in connection with the sale of motor vehicles.

The website located at "www.autoworldoftexas.com" contains information about a business named Auto World of Texas located at 8321 Hempsted (sic) Rd. in Houston, Texas. The website contains a tab labelled "Financing" which is a hyperlink to a "Retail Motor Credit Application." The "Retail Motor Credit Application" has two options – one for a "Credit Sale" and the other for a "Lease." The website also contains a tab labelled "Inventory" which is a hyperlink to a list of vehicles for sale. For each listed vehicle, there is a green box with the words "AUTO FINANCE IT'S EASY TO APPLY TODAY!" The green box is a hyperlink to a "Retail Motor Credit Application" with a "Credit Sale" option. This application contains a statement reading:

The words "you" and "your" refer to each person or business submitting this application. The words "we", "us" and "our" refer to the seller and the financial companies to which your application is submitted....

You authorize us to obtain consumer credit reports from time to time as we want, for any legitimate purpose, in connection with the transaction that is proposed by this application or any future update, renewal, or extension of that transaction. Upon request, you will be informed whether or not a consumer report was ordered. If a report was requested, you will be informed of the name and address of the consumer credit reporting agency that furnished the report. We may keep this application whether or not it is approved. You authorize us to check your credit and employment history and to answer questions others may ask us about your credit record with us.

You agree that your telephone communications with us and any financial company that reviews this credit application may be monitored and/or recorded to assure the quality of service. You give your consent to receive calls and text messages from the creditor or its third party debt collector at any number you have given us, including calls and messages made using

an autodialer or prerecorded message. You agree that we can send disclosures or other communications to you electronically at the e-mail address you have given us.

Therefore, the "Retail Motor Credit Application" is an offer by Pyne RV to finance the sale of the motor vehicles advertised on its website through a retail installment transaction.¹³

The website located at "www.autoworldoftx.com" also contains information about a business named Auto World of Texas located at 8321 Hempstead Rd. in Houston, Texas. The website contains a tab labelled "Financing" which is a hyperlink to a "Secure Loan Application." The website also contains a tab labelled "Inventory" which is a hyperlink to a list of vehicles for sale. For each listed vehicle, there is a box with the words "Loan Application." The box is a hyperlink to a "Secure Loan Application." This application contains a statement reading:

By submitting this application, I am applying for credit with this dealership or a designated financing source...I authorize this dealership and any potential financing source to retain this application, to check and verify my credit, employment, and salary history. By using the dealers website, I authorize them to provide reports on the status of my credit application, including information concerning whether I pre-qualify for a loan, which lender's loan offer (if any) I choose to accept, whether my application for credit is denied, and whether I accept a loan from the specified lender.

Therefore, the "Secure Loan Application" is an offer by Pyne RV to finance the sale of the motor vehicles advertised on its website through a loan. 14

Pyne RV does not currently hold a dealer's license (general distinguishing number) issued by the Texas Department of Motor Vehicles authorizing it to sell motor vehicles under its own name or under the name Auto World of Texas. ¹⁵ The only dealer licensed to operate at 8321 Hempstead Road in Houston, Texas is R.V. Suppliers, Inc., whose license number is P17887. R.V. Suppliers, Inc. is not licensed to sell motor vehicles under the name Auto World of Texas. R.V. Suppliers, Inc. has not filed an assumed name certificate with the Texas Secretary of State to do business under the name Auto World of Texas.

Pyne RV does not currently hold an OCCC license to finance the sale of motor vehicles through a retail installment transaction under Chapter 348 under its own name or under the name Auto World of Texas. Pyne RV previously held a Chapter 348 license issued by the OCCC under the assumed name "Auto World of Texas" for the business located at 3233 West 11th Street in Houston, Texas. The OCCC license number was 64266 under master file number 13356, and was active from September 11, 2012, through August 13, 2015. Since Pyne RV does not hold an OCCC license to finance the sale of motor vehicles, it is engaging in unlicensed activity, and is placing false, misleading, and deceptive advertisements on its website. ¹⁶

Pyne RV has never, and does not currently, hold an OCCC license to make, transact, or negotiate a loan subject to Chapter 342 under its own name or under the name Auto World of Texas. Transacting a loan includes the act of arranging a loan. Negotiating a loan includes the act of passing information between a borrower and a lender in order to reach agreement on the terms of a loan. Since Pyne RV does not hold a Chapter 342 OCCC license, it is engaging in unlicensed activity, and is placing false, misleading, and deceptive advertisements on its website.

Texan RV Ltd. d/b/a Auto & RV World of Texas

Pyne RV Rentals, Inc. is the general partner in a limited partnership named Texan RV Ltd. (Texan RV). Texan RV held licenses to sell motor vehicles issued by the Texas Department of Motor Vehicles under license (general distinguishing) numbers P51402 and P5586X.²⁰ Both licenses listed 26304 Katy Freeway in Katy, Texas as their business address. Neither license authorized Texan RV to conduct business at 8321 Hempstead Road in Houston, Texas.²¹

License number P5586X listed an assumed name of "Auto & RV World of Texas" while license number P51402 listed no assumed name. Records of the Texas Secretary of State reflect that Texan RV was authorized from October 4, 2006 to October 4, 2016, and July 16, 2019 to July 16, 2029, to conduct business under the assumed name of "Auto & RV World of Texas." ²²

Texan RV does not currently, and has never, held a licensed issued by the OCCC. Nevertheless, Texan RV has entered into retail installment contracts in connection with the sale of a motor vehicle without an OCCC motor vehicle sales finance license.²³ Specifically, an e-TAG report from the Texas Department of Motor Vehicles shows that Texan RV placed liens on at least three vehicles since May 2017. Texan RV's placement of the lien necessarily reflects that it has accepted part or all of the cash price of the vehicle in one or more deferred

installments,²⁴ which requires an OCCC motor vehicle sales finance license.²⁵ In addition, Texan RV appears to have engaged in the financing of motor vehicle sales in 42 transactions where the retail installment contracts were transferred and assigned to Westlake Services. Therefore, Texan RV has violated Section 348.501 of the Texas Finance Code.²⁶

Authority

If the Commissioner has reasonable cause to believe that a person is violating Chapter 348 of the Texas Finance Code, the Commissioner may issue an order to cease and desist from the violation, an order to take affirmative action, or both to enforce compliance.²⁷ Additionally, the Commissioner may order a person who violates Chapter 348 or a rule adopted under Chapter 348 to make restitution to an identifiable person injured by the violation.²⁸

Order

IT IS ORDERED that Pyne RV Rentals, Inc. d/b/a Auto & RV World of Texas, Texan RV Ltd. d/b/a Auto & RV World of Texas, and Pyne RV Rentals, Inc. d/b/a Auto World of Texas:

- 1. comply with the motor vehicle sales finance license requirement, found in Sections 342.051 and 348.501 of the Texas Finance Code;
- 2. cease any and all unlicensed activity under Chapters 342 and 348 of the Texas Finance Code;
- 3. review all motor vehicle sales transactions from **August 13, 2015 to October 1, 2019** to identify each retail installment transaction in

which it acted as a holder without a license under Chapter 348;

- 4. review all motor vehicle sales transactions from **August 13, 2015 to October 1, 2019** to identify each transaction it made, transacted, or negotiated, or charged or received a charge, subject to Chapter 342 of the Texas Finance Code without the required license;
- 5. no later than **December 1, 2019**, refund all finance charges that you collected or that remain collectible in the transactions you identified above;
- 6. no later than **December 1, 2019**, provide the OCCC with a spreadsheet of all transactions you identified and all buyers that you gave a refund. This list must include the buyer's name, account number, transaction date, amount financed, amount of finance charges, and refund amount; and
- 7. keep a copy of each customer's refund check or payment history showing an account credit until the expiration of the required retention period.²⁹

Violation of Order

You may be assessed and administrative penalty of up to \$1,000 for each day of violation of this Order.³⁰

Right to Request Hearing

Pyne RV and Texan RV have the right to request a hearing regarding this Order.³¹ Either party's request must be made in writing and sent to the OCCC not later than 30 days after each party receives this Order. The requesting party must send its request to:

On October 23, 2019 the Office of Consumer Credit Commissioner ("OCCC") Order to Cease and Desist, to Take Affirmative Action, and to Make Restitution (the "Order") against Pyne RV and Texan RV for engaging in unlicensed activity under Chapter 348 of the Texas Finance Code.

More than thirty days have passed since Pyne RV and Texan RV received the Order, and Pyne RV and Texan RV have not requested a hearing. The Order is now final and enforceable pursuant to Section 14.208(c) of the Texas Finance Code. A copy is enclosed for your convenience.

The order requires Pyne RV and Texan RV to cease and desist entering or collecting payments on retail installment contracts and to refund finance charges on motor vehicles. The order requires Pyne RV and Texan RV to send a spreadsheet of motor vehicle sales transactions from August 13, 2015 to October 1, 2019, by email to michael.rigby@occc.texas.gov by December 1, 2019. Pyne RV and Texan RV have not complied with the Order. Pyne RV and Texan RV must immediately make the restitution and provide the OCCC with the spreadsheet of the refunds required by the Order, to me at michael.rigby@occc.texas.gov no later than 10 days from the date of this correspondence. Administrative penalties may be assessed at a rate of up to \$1,000 per day for each day that Pyne RV and Texan RV fail to comply with the Order.
