ORDER TO FILE TIMELY AND ACCURATE ANNUAL REPORTS

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order to File Timely and Accurate Annual Reports against Smart Pawn And Jewelry Of Texas, LLC (“Smart Pawn and Jewelry of Texas”).¹

Statement of Facts and Law

Smart Pawn and Jewelry of Texas is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Smart Pawn and Jewelry of Texas operates under master file number 1800060514 at eleven licensed locations, under license numbers 159674, 159675, 159676, 159677, 159678, 159679, 159680, 159681, 159682, 159683, and 159684. Smart Pawn and Jewelry of Texas’s compliance officer is Christian Schroder, and its designated contact address is 5728 Major Blvd., Suite 100, Orlando, Florida 32819.

A pawnshop must file annual reports with the Consumer Credit Commissioner (“Commissioner”).² For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year’s activity, and must comply with all instructions relating to submitting the report.³

Smart Pawn and Jewelry of Texas did not file its 2018 annual report with the Commissioner for licensed location numbers 159674, 159675, 159676, 159677, 159678, 159679, 159680, 159681, 159682, 159683, and 159684 by July 31, 2019.

The Commissioner may issue an injunction ordering a pawnshop to file

one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the pawnshop is violating Chapter 371 of the Texas Finance Code.⁴

The Commissioner has reasonable cause to believe that Smart Pawn and Jewelry of Texas is violating Chapter 371 of the Texas Finance Code, and therefore issues this Order, because Smart Pawn and Jewelry of Texas failed to timely file its 2018 annual report.

Order

IT IS ORDERED that Smart Pawn And Jewelry Of Texas, LLC:

1. comply with, and cease and desist from violating, the reporting requirements set forth in 371.201 of the Texas Finance Code and Title 7, Section 85.502 of the Texas Administrative Code;
2. file its 2018 annual report within 30 days of service of this Order, if it has not already done so; and
3. timely file complete and accurate future annual reports.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705 through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occ.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occ.texas.gov.

Violation of Order

If you violate this Order, the OCCC may impose an administrative penalty of up to \$1,000 for each day.⁵ Multiple violations may also result in the suspension or revocation of your license.⁶

Right to Request Hearing

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁸ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.⁹
