ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against Good Day Corporation (“Good Day Corporation”).¹

Statement of Facts and Law

Good Day Corporation is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Good Day Corporation operates under master file number 15483 at one licensed location, under license number 57548. Good Day Corporation’s compliance officer is Maria Del Pilar Buendia, and its designated contact address is 14696 Montana, Suite 300, El Paso, Texas 79938.

A pawnshop must file annual reports with the Consumer Credit Commissioner (“Commissioner”).² For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year’s activity, and must comply with all instructions relating to submitting the report.³

Good Day Corporation did not file its 2019 annual report with the Commissioner for one licensed location, under license number 57548 by July 31, 2020.

On October 21, 2019, the OCCC issued an Order to File Timely and Accurate Annual Reports (the “Order”) against Good Day Corporation for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2018 annual report. The Order required Good Day Corporation to timely file all future annual reports.

Good Day Corporation did not file its 2019 annual report with the Commissioner for one licensed location, under license number 57548, by July 31, 2020. Good Day Corporation violated the Order by failing to timely file its 2019 annual report and is therefore subject to an administrative penalty for violation of the Order.⁴

Order

IT IS ORDERED that Good Day Corporation:

1. pay an administrative penalty in the amount of **\$500.00**, calculated as \$500.00 each for Good Day Corporation’s one licensed location, within 30 days of service of this Order; and
1. file its 2019 annual report within 30 days of service of this Order, if it has not already done so.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or through the OCCC’s Application Licensing Examination and Compliance System (ALECS): alecs.occ.texas.gov. Instructions are available by clicking the “File Annual Report” button on the OCCC’s home page, occ.texas.gov.

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁶ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.⁷
