ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Assessing Administrative Penalty for Violation of Injunctive Order against Cayle Womack d/b/a Cash-N-Go (“Cash-N-Go”).¹

Statement of Facts and Law

Cash-N-Go is a credit services organization licensed to act as a credit access business under Chapter 393 of the Texas Finance Code. Cash-N-Go operates under master file number 16523 at one licensed location, under license number, 62588. Cash-N-Go’s compliance officer is Cayle Womack, and its designated contact address is 1315 Martin Luther King, San Angelo, Texas 76903.

A credit access business must file quarterly and annual reports with the Consumer Credit Commissioner (“Commissioner”).² A credit access business must submit its quarterly and annual reports on or before the following dates:

- 1st quarter report – April 30;
- 2nd quarter report – July 31;
- 3rd quarter report – October 31; and
- 4th quarter and annual report – January 31.³

If a credit access business violates the quarterly or annual reporting requirements for a second time within four quarters of a first reporting violation,

the OCCC may impose an administrative penalty against the credit access business of \$500.00 for each of its licensed locations.⁴ If a credit access business fails to file a quarterly or annual report again within four quarters of a second reporting violation, the OCCC may impose an administrative penalty of \$1,000.00 against the credit access business for each of its licensed locations.⁵ The OCCC may seek revocation for any subsequent violation of the reporting requirements within four quarters of a third or subsequent reporting violation.⁶

On November 24, 2020 the OCCC issued an Order to File Timely and Accurate Quarterly and Annual Reports against Cash-N-Go for failing to file its 2020 3rd quarter report.

Cash-N-Go did not file its 2021 2nd quarter report with the Commissioner on or before July 31, 2021. Additionally, Cash-N-Go did not timely file one or more of its reports within the four quarters preceding the 2021 2nd quarter report.

Order

IT IS ORDERED that Cayle Womack d/b/a Cash-N-Go:

1. pay an administrative penalty in the amount of **\$500.00**, calculated as \$500.00 each for Cash-N-Go's one licensed location, within 30 days of service of this Order; and
2. file its 2021 2nd quarter report within 30 days of service of this Order, if it has not already done so.

Credit access business quarterly and annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occ.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occ.texas.gov.

Right to Request Hearing

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁸ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.⁹
