ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against Preston Jewelry & Loan Co. Inc. d/b/a Bishop Pawn & Jewelry #7 (“Preston Jewelry & Loan”).¹

Statement of Facts and Law

Preston Jewelry & Loan is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Preston Jewelry & Loan operates under master file number 2572 at one licensed location, under license number 5612. Preston Jewelry & Loan’s compliance officer is Pat Bishop, and its designated contact address is 124 West Jefferson Blvd., Dallas, Texas 75208.

A pawnshop must file annual reports with the OCCC.² A pawnshop must comply with all instructions from the OCCC relating to submitting the report, and must file a report for each licensed location.³ The report is due by July 31 of each year for the prior calendar year’s activity.⁴

On October 10, 2024, the OCCC issued an Order to File Timely and Accurate Annual Reports (the “Order”) against Preston Jewelry & Loan for failing to timely file its 2023 annual report. The Order required Preston Jewelry & Loan to timely file complete and accurate future reports.

Preston Jewelry & Loan did not file its 2024 annual report by the deadline of July 31, 2025.

The Consumer Credit Commissioner (“Commissioner”) may issue an injunction ordering a pawnshop to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the pawnshop is violating Chapter 371 of the Texas Finance Code.⁵ The Commissioner may impose an administrative penalty on a pawnshop that violates an injunction.⁶

By failing to timely file its 2024 annual report, Preston Jewelry & Loan has violated Chapter 371 of the Texas Finance Code and the OCCC’s Order to File Timely and Accurate Annual Reports.

Order

IT IS ORDERED THAT Preston Jewelry & Loan Co. Inc. d/b/a Bishop Pawn & Jewelry #7:

1. pay an administrative penalty in the amount of \$750.00 (calculated as \$750.00 each for Preston Jewelry & Loan’s one licensed location) within 30 days after the date of this Order; and
2. file its 2024 annual report within 30 days of the date of this Order, if it has not already done so.

Pawnshop annual reports must be submitted through the OCCC’s Application Licensing Examination and Compliance System (ALECS): alecs.occctexas.gov. Instructions are available by clicking the “File Annual Report” button on the OCCC’s home page, occctexas.gov.

Right to Request Hearing

You have the right to request a hearing regarding this Order.⁷ To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after the date of this Order.⁸ You must send your request to Vivek Vedanarayanan, Assistant General Counsel, by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or by email to vivek.vedanarayanan@occc.texas.gov.

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁹ If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.¹⁰
